SPECIFICATION

The development comprises 17,500 sq ft of trade counter units built in a terrace with car parking/yard to the front built on a site 1.2 acres.

The specification for the units is as follows:

- Steel portal frame construction
- Part brick, part insulated clad elevations
- Insulated clad roof incorporating 10% translucent roof lights
- 6m to haunch
- Ground floor glazing and entrance to allow for specific occupier fit outs for trade counter uses
- 3 phase electricity
- Individual service supplies
- Shared yard/car parking area with designated car parking spaces for each unit
- Full height loading door for each unit
- Provision of breeze block and stud division walls for each unit


